- 3. Redemption can only be processed upon being fully furnished with the Mastercard cardholder's particulars, purchase details and indication of consent or otherwise to receiving future direct communications from The Management for audit and verification purposes.
- 4. This promotion is only valid for purchases made at Takashimaya Shopping Centre Specialty Stores from Basement 2 to Level 4.
