Terms and Conditions

2. Original printed receipt(s) must be presented during redemption. Duplicated/re-printed receipt(s) will not be accepted.
3. Redemption can only be processed upon being fully furnished with the shopper's/cardholder's particulars, purchase details and indication of consent or otherwise to receiving future direct communications from The Management for audit and verification purposes.
