HOW TO APPLY FOR YOUR TAX REFUND

At the store

Spend a minimum of SGD100 in up to 3 same-day receipts to meet this minimum purchase amount.

Present your original passport in person, valid Electronic Visit Pass (e-Visit Pass) sent through the email address declared in the SG arrival card and eligible receipt(s) to the store staff. They will digitally capture your passport details to assist you in applying for a GST refund. For Takashimaya Department Store purchases, please proceed to the Global Tax Free (GTF) counter located at Customer Service Centre, Level 3.

PLEASE NOTE: The GST Refund application must be issued at the time of sale of goods on the same day.

Retailers will only accept your original passport and a valid e-Visit Pass when applying for your GST refund.

At the airport

Proceed to the eTRS self-help kiosk before check-in of luggage with your purchases, receipts, original passport and travel documents.

Scan your passport at the eTRS self-help kiosk to retrieve your tax free transaction details. Follow the instructions shown to complete the tax refund process.

Do not pack away your purchases in your check-in luggage as you may be required to present your goods and original invoice/receipt at the Customs Inspection Counter.

PLEASE NOTE: For cash refunded in excess of SGD7,500 from a single receipt or accumulated multiple receipts, an administration fee ranging from SGD100 to SGD199 is payable at the GST cash refund counter.

如何申请退税

在商店

最多3张当天收据中消费至少SGD100即可满足此最低购买金额。

请亲自将您的护照原件、通过新加坡入境卡上声明的电子邮件地址发送的有效电子访问通行证 (e-Visit Pass) 以及符合收据出示给店员。他们将以数字方式捕获您护照的详细信息，以帮助您申请GST退税。

请注意：GST退税申请必须在当天销售商品时发出。

在您申请GST退税时，零售商只接受护照原件以及有效电子访问通行证 (e-Visit Pass)。

在机场

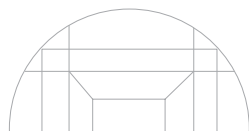
请您在托运行李之前先携带您的退税商品、收据、护照原件和旅行证件前往eTRS自助退税服务柜台。

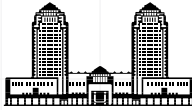
在eTRS自助退税服务柜台扫描您的护照，以检索您的退税交易详情。按照显示的说明完成退税流程。

请勿将您的退税商品放在托运行李中。您可能需要在海关检查柜台出示您的退税商品和原始发票/收据。

请注意：如果单笔或累计多次收据的现金退税价值超过SGD7,500，则需支付给GST现金退税柜台SGD100至SGD199的行政费。
