4. DBS Takashimaya Credit Cards, original printed receipt(s) and corresponding charge slip(s) must be presented during redemption. Duplicated/re-printed receipt(s) will not be accepted.
5. Redemption can only be processed upon being fully furnished with the cardholder's particulars, purchase details and indication of consent or otherwise to receiving future direct communications from The Management for audit and verification purposes.
